
IATI Legal & Accounting Committee


IATI Lablor Law Workgroup

The new IATI Labor Law Workgroup has officially launched. Operating under IATI's Legal & Accounting Committee, the Group will focus on labor law issues impacting the industry — and especially, how to create order in a constantly changing landscape. The kickoff meeting was held at S. Horowitz & Co., and included an open discussion where the group's main areas of focus were defined.

At the initiative of the group's members, an additional session was held with senior HR representatives from several global companies, members of IATI. The meeting aimed to deepen the understanding of current labor law challenges in Israeli high-tech and to help shape the group's future activities and priorities.

'Meshuhreret-Tech' Program 2025

Meshuhreret-Tech is an initiative designed to encourage discharged female soldiers with strong mathematical skills to pursue academic studies and careers in engineering and technology. Led by IATI and the Socio-Economic Forum, in partnership with the IDF's "Sha'ar Leatid", the Ministry of Defense (Discharged Soldiers Department), Israel Aerospace Industries (IAI), and the Israeli Presidency of Business Organizations, the program combines foundational courses in technological fields, personal mentoring by industry leaders, and visits to leading companies. Together, these elements provide participants with tools, knowledge, and confidence to build their future in Israel's high-tech and engineering sectors.

We are proud to mark the conclusion of the third cohort of Meshuhreret-Tech. The cohort wrapped up with a closing event at ELTA in Ashdod, which included opening remarks, the awarding of certificates, and a lecture on innovation and technological development.
